Against this backdrop, the 9<sup>th</sup> Annual Economics Conference of the Sarla Anil Modi School of Economics seeks to provide a vibrant platform for academic researchers, policymakers, industry practitioners, and development professionals to engage in informed dialogue on contemporary macroeconomic issues affecting both the real and financial sectors of the economy. The conference aims to foster interdisciplinary exchange and evidence-based policy discussions that contribute to addressing current and future economic challenges.
