**1. Introduction:**

This booklet gives information about the Admission Procedure and Admission Test for M.Sc. Economics – Mumbai Campus

This is a full time two years course, comprising of four semesters.

**3. Important Dates:**

Start date for online Registration : Wednesday, 20<sup>th</sup> January'2021  
Last date for online Registration : Sunday, 20<sup>th</sup> June'2021  
Written Test & Personal Interview : Friday, 02<sup>nd</sup> July'2021 (virtual mode)

**4. Eligibility criteria:** (Fulfillment of all / applicable conditions mandatory)

4.1 The candidate must be a graduate in any stream from a recognized University and should have obtained a minimum of 60% aggregate marks.

4.2 Candidate must have passed Mathematics or Statistics in their 10+2 or equivalent examination **AND** at the Graduation level.

4.3 Candidates should mention in the online registration / e-admission form (if selected) all the subjects which the candidate has taken & appeared for (not best of four, five, six or seven). The candidate shall have passed all the subjects, which he / she has taken & appeared for in the applicable examination/s. The aggregate percentage of all subjects that the candidate has taken & appeared for will be taken into consideration for confirming the eligibility of the candidate for the program at the time of admission.

4.4 In case the mark sheet issued by applicable board / University is in percentile/s or Grade point the actual aggregate percentage of all subjects appeared by the candidate will be taken into consideration.

4.5 Candidate awaiting the results of the final year examination may also apply.

4.6 Candidates called for admission based on merit list and who do not have final mark sheet will be given "provisional admission". Fees will be accepted from such candidates but their admission will be confirmed on submission of final mark sheet.

- 4.7 Candidate whose final mark sheet is not available at the time of admission is required to upload internet copy of result duly attested by Principal of the school / college with official seal, failing which candidate will not be admitted for the program
- 4.8 Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their examination from Overseas Universities.
- 4.9 Candidates who have cleared their graduation by doing a part time course or through distance learning, correspondence course externally, open school from a recognized University are eligible to apply & register as per UGC guidelines.

## **5. Admission Process:**

### **5.1 Online Registration & Payment of Registration:**

- Visit [www.nmims.edu](http://www.nmims.edu) for online registration
- Before filling the online form, please read all the instructions carefully mentioned in the instruction sheet, important dates and Terms & Condition given in the online application form.
- Online Registration Fee of Rs.2000/- plus applicable taxes (Please refer online registration for payment details.)
- Registration Fee is non-refundable.

### **5.2 Admission Process / Call letter :**

- Candidates, who are registered successfully, only will be confirmed for Written Test & Personal Interview.
- Candidates are required to download the call letter from our website [www.nmims.edu](http://www.nmims.edu) and upload below mentioned document. No separate call letter will be mailed or posted to the candidates.

#### **List of Documents:**

- 1) Copy of duly filled online application form
  - 2) 10<sup>th</sup> mark sheet & passing certificate
  - 3) (10+2) or equivalent mark sheet and passing certificate
  - 4) Degree mark sheet & Degree certificate
- Candidate's application form will not be considered if they fail to upload the above-mentioned documents till Monday, 28<sup>th</sup> June'2021.
  - The entrance examination will be done through google form and the personal interviews will be held on MS Teams /Zoom Platform.

- The link for the Entrance examination & Call Letter will be mailed to your registered email id. The Interviews will be scheduled as per the important dates mentioned on the website.
- The candidate must be available as per the mentioned time given in the call letter. Candidate should have desktop/laptop for taking the entrance examination with proper internet connection.

## 6. Selection Process:

All candidates who are registered successfully will be called for a Written Test & Personal Interview conducted by NMIMS.

- Written Test : Maximum Marks 80

SECTION	SUBJECT	No. of Questions	Max. Marks
Section I	Quantitative Aptitude	15 Questions	30 Marks
Section II	Logical Reasoning	10 questions	20 marks
Section III	Data Interpretation	10 Questions	20 marks
Section IV	General Awareness	5 Questions	10 marks

Quantitative Aptitude section will include

- 1) Algebra- Solutions to system of equations
- 2) Calculus – Differentiation and integration
- 3) Basic probability

Personal Interview : Maximum Marks: 20

- Final merit list will be prepared on the basis of the marks obtained in the Written Test & Personal Interview.
- Admission offer is given as per merit and vacancy. WAITLISTED candidates have to check their merit list status as per date given on the website. SELECTED candidate should upload necessary required document at the link provided in the admission offer letter, and after verification of the uploaded documents; the candidate will get the payment link (RTGS / NEFT details) for the payment of course fees within the stipulated time frame.
- The selection will be solely based on merit.
- The cut-off for deciding the merit shall lie solely with NMIMS.

## 7. Program Fees for batch 2020: (for information only)

Program fees for 1<sup>st</sup> year M. Sc. Economics were Rs.2,01,500/-

Fees for 1<sup>st</sup> year M.Sc. Economics (Batch 2021) will be declared at the time of admission.

## 8. Refund Rule:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission. <b>(on &amp; before 06<sup>th</sup> August'2021)</b>
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission. <b>(07<sup>th</sup> August – 22<sup>nd</sup> August'2021)</b>
(3)	80%	15 days or less <b>after</b> the formally notified last date of admission. <b>(23<sup>rd</sup> August'2021 – 06<sup>th</sup> September'2021)</b>
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally notified last of admission <b>(07<sup>th</sup> September'2021 – 21<sup>st</sup> September'2021)</b>
(5)	00%	More than 30 days <b>after</b> formally notified last date of admission. <b>(22<sup>nd</sup> September'2021)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: 1) The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).

## 9. Important Instructions:

- **For cancellation/ withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate should email at [admissioncancellation@nmims.edu](mailto:admissioncancellation@nmims.edu), the soft copy of admission cancellation form duly filled and signed fee paid receipt copy & cancelled cheque (personal account).

- Please see the important dates and preserve it as a guide. All announcements from the institute will be through its website [www.nmims.edu](http://www.nmims.edu) and no individual communication will be sent to the candidates. Kindly check the website regularly for any updates.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/ her in the application form is incorrect, his/her application for the admission to the program, even if selected, will stand cancelled and fees will be forfeited.
- Candidate's documents will be verified online (if selected) & if found not eligible, admission will be cancelled and fees will be forfeited.
- Canvassing in any form will disqualify the candidate.

- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. No separate intimation will be given.
