Note: The candidates must check his/her eligibility before applying for the course.

Refund Rule: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission. (on & before 06th August'2021)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (07th August – 22nd August'2021)
(3)	80%	15 days or less after the formally notified last date of admission. (23rd August'2021 – 06th September'2021)
(4)	50%	30 days or less, but more than 15 days, after formally notified last of admission (07th September'2021 – 21st September'2021)
(5)	00%	More than 30 days after formally notified last date of admission. (22nd September'2021)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: 1) The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable).

2) Candidates to refer Important Dates of the respective programme
