Refund Rule: If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission. (on & before 14th July'2023)

(2)	90%	Less than 15 days before the formally-notified last date of admission. (15th July'2023 – 30th July'2023)
(3)	80%	15 days or less after the formally notified last date of admission (31st July'2023 – 14th August'2023)
(4)	50%	30 days or less, but more than 15 days, after formally notified last of admission (15th August'2023 – 29th August'2023)
(5)	00%	More than 30 days after formally notified last date of admission. (30th August' 2023 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: 1) The above refund rules are subject to revision as applicable
